

SEYBERT- SEPTEMBER GRANTS DEADLINE MOVED TO JUNE, and other deadline news

Dear Nonprofit Partners,

After months of strategic planning, the Seybert Foundation will be announcing our new funding strategy soon. The goal of our planning process is to increase the impact of Seybert's General Operating grants supporting youth-serving nonprofit organizations in Philadelphia.

The new grant application and report forms will be posted online on APRIL 15th, 2018. All applicants and grantees are encouraged to visit the website for details about the new strategy and the new forms at that time. Deadlines for both grant applications and reports have changed, so please read this carefully to ensure timely submission of your Seybert application and/or reports this year:

NEW Grant Application Deadlines

- **May 15, 2018:** New deadline for Spring grant applications (formerly March 15th). Applicants who submit a grant proposal by this date will be notified of their grant award status by June 30, 2018.
- **June 15, 2018:** New deadline for "Fall" grant applications (formerly September 15th). Applicants who submit a grant proposal by this date will be notified of their grant award status by July 31, 2018.

To reiterate, THERE WILL BE NO SEPTEMBER DEADLINE FOR SEYBERT GRANTS IN 2018. ALL 2018 GRANTS MUST BE SUBMITTED FOR EITHER THE MAY 15th or JUNE 15th DEADLINES.

NEW Grant Report Deadlines

If you received a grant from Seybert Foundation in 2017, you were originally asked to submit a final report by either March 15th or September 15th, 2018, depending on the date of your funding award. These reporting dates have changed, as well. The new reporting form will be posted online on April 15th, 2018, and the new deadlines for reports are:

- **May 15, 2018:** New reporting deadline for grants that were awarded in May/June, 2017 (These reports were formerly due on March 15th. If you are submitting a new grant application for the May 15th deadline and you received a grant from us last Spring, then your report on that grant is due at the same time as your new application.)
- **December 15, 2018:** New reporting deadline for grants that were awarded in November/December, 2017 (These reports were formerly due on September 15th.)

Therefore, if you were awarded a grant from Seybert in November or December of 2017, your final report is NOT due until December 15, 2018, even if you submit a new application for our June 15, 2018 deadline because not enough time has passed. We also wanted to give you a few extra months to complete the report out of consideration for your time, since we are moving the Fall application deadline UP by three months, to June 15, 2018, and we know that changes your grantwriting plans.
